The St Croix County Treasurer will be collecting the real estate and personal property taxes for the **CITY OF HUDSON, TOWNS OF HUDSON, TROY AND ST JOSEPH**, due by January 31, 2018. Questions or concerns regarding your real estate and personal property taxes should be made to your local municipality.

IN PERSON – Pay by check or cash, St. Croix County Treasurer's Office, 1101 Carmichael Road, Hudson. Hours are 8:00 a.m. to 5:00 p.m. Monday through Friday, or deposited in the night deposit on the outside of the building. Any monies put into the night deposit box by December 31, 2017 – will be receipted as of 12-31-17.

US MAIL – St. Croix County Treasurer, 1101 Carmichael Road, Hudson, WI 54016 – **Must be postmarked on or before January 31, 2018.** For year end payments (Dec 31) your receipt will show the date payment was received not the postmark date.

E-CHECK (ACH DEBIT) - \$ 1.50 Charge Per Parcel. Internet at www.sccwi.us / Click on "Pay Taxes Online"

CREDIT CARD – 2.39% Service Charge - Internet at www.sccwi.us / Click on "Pay Taxes Online" (Allow up to 3 days for payment to be applied even though it says "Same Day Pay")
